


Ideal installation conditions are +20°C (+68°F) / 50% RH. For exceptional conditions, please contact Confidex. Bond strength can be improved with firm application pressure.

Minimum bending diameter of the Confidex LoopTag $^{\text{TM}}$ is defined to be 50mm, excluding the strap part. Never touch on the location of the IC. Tag polarization should be taken into account in case liner polarized reader antennas are used.



When printing the label align the printer gap trigger as shown below for smooth operation.
